That RAANZ removes the requirement for Club secretary and president sign of on the application form for a RAANZ Instructor certification. Secondly that the requirement for a recommendation as to suitability to be an instructor be a requirement for the training and ATO on the CMV.

A lengthy discussion ensued on this remit to change the Exposition (not the Constitution) in an effort to convince the meeting of the need and then to find a workable acceptable solution. The consensus was that this is an issue for the exec committee to consider in consultation with CAA. The remit was formally put to the vote (**M** Glenn Martin/CRAC, **S** Glenn Martin/GFG) and **failed** the vote -CRAC/GFG for (24%), Gyrate nil vote, remainder against (40%)
